## METEF 2022 INTERNATIONAL INNOVATION AWARD

### REGULATIONS

#### 1) Purpose

The **Metef 2022 Innovation Award** is intended to valorise the innovative content proposed by companies in the different areas of interest at the 2022 edition of the exhibition. The innovative content proposed will be evaluated based on the degree of originality and innovation, the performance features, and the competitive advantages that they are able to offer, favouring in particular the aspects of **energy savings, eco-sustainability and safeguarding of resources** contained in the proposals, as well as connections with universities and institutes of technology transfer. During the evaluation phase the access to national and communitarian public funds for the innovation will also be valued.

A special prize will be awarded to the decarbonisation projects of the company system as a whole.

#### 2) Categories

The award, with its international nature, intends to give a prize for the best examples of innovation applied to the production, transformation, machining and use of metal products or components, realized in each of the following sections:

- **materials**
- **machinery and plants**
- **technologies and processes**
- **products, components, systems**
- **applications**
- **decarbonisation processes of the company system**
- **other.**

Proposals at the prototype stage will also be considered.

#### 3) Participation Conditions

Participation is open to all Italian and International companies exhibiting at Metef 2022, who intend to present their innovative contents in the various categories of the award. Participation in the contest is free of charge.

- 2) Illustrative Sheet (Appendix B)
- 3) Iconographic material (Photographs, design drawings, operating diagrams) (*Digital format allowed TIF, JPG, EPS, PDF, 300 dpi minimum resolution*).
- 4) Other technical and iconographic supporting documentation aimed at demonstrating the innovative nature of the proposal (construction drawings, images, - technical sheets, projects, lay-out, descriptive technical publications, patents, etc.) and the consequent competitive advantage (competitive context, relationship costs / benefits...) (digital format allowed TIF, JPG, EPS, PDF, minimum resolution 300 dpi).
- 5) Documentation related to any existing request for access to national and communitarian public funds for the innovation.
